

SPECIAL MEETING

AUGUST 26, 2004

A Special Meeting of the Arcadia City Council was held on August 26, 2004 at 8:00 a.m. in conjunction with the DeSoto County Commission at the Emergency Management Operations Center at 201 E. Oak Street. Council Members attending were: Fazzone, Whitlock, Heine, Johnson and Goodman. Also in attendance were: Administrator Strube, and City Attorney Holloman.

Council stated that an amendment is necessary to Emergency Ordinance No. 912. Whitlock moved to amend Emergency Ordinance 912 as adopted on August 18, 2004; seconded by Goodman and carried.

EMERGENCY ORDINANCE NO. 912 - AMENDED

AN EMERGENCY ORDINANCE OF THE CITY OF ARCADIA, FLORIDA, AMENDING ORDINANCE NO. 912 AS PREVIOUSLY AMENDED; TO EXEMPT PERSONS LAWFULLY GOING TO AND FROM WORK, AND CHANGING THE HOURS OF CURFEW FROM BEING BETWEEN THE HOURS OF 8:00 PM AND 6:00AM TO BEING BETWEEN THE HOURS OF 9:00 PM AND 6:00 AM; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Arcadia, Florida, finds that it is in the best interests of the City of Arcadia and its citizens that persons going to and from work be exempted from Ordinance No. 912 imposing a curfew; and,

WHEREAS, the City Council of the City of Arcadia, Florida, further finds that the hours of curfew can now be changed from 8:00 PM to 6:00 AM to 9:00 PM to 6:00 AM

BE IT ORDNANED BY THE CITY COUNCIL OF THE CITY OF ARCADIA, FLORIDA, THAT SECTION 2 OF EMERGENCY ORDINANCE NO. 912 OF THE CITY OF ARCADIA, FLORIDA IS HEREBY AMENDED TO READ AS FOLLOWS:

Section 2. That a curfew prohibiting all persons, except government officials and persons lawfully going to and from work, from being on the public streets and public roads, except in the event of an emergency, is hereby imposed between the hours of ~~8:00 PM~~ 9:00 PM and 6:00 AM so long as this amended emergency ordinance is in effect.

All other provisions of Ordinance No. 912 shall remain in full force and effect.


